## Sub: Extension of CGHS facility.

## Dear Sir,

I am writing this letter to empanelment of your hospital for treatment of our employees and their family members who are covered under our medical scheme.

The Department of Biotechnology (DBT), Ministry of Science & Technology (Government of India) has established the Regional centre For Biotechnology (RCB) as a part of an emerging biotech bioscience cluster. It also seeks to establish collaborations with research institutions and hospitals around India, making this a national undertaking. This institute is located at NCR- Biotech Science Cluster, 3rd Milestone, Faridabad - Gurgaon Expressway, Faridabad-121001 (PO Box no. 04).

RCB is at present following the Medical Attendance rules of the Government of India for providing reimbursement of medical bills of our employees. It is now proposed to have a robust medical attendance scheme for our employees on the lines of the Central Government Health Scheme (CGHS). Accordingly, we found that you are one of the empanelled hospitals under the CGHS for various specialties. In view of the above, we wish to empanel your hospital as one of our recognized hospitals for treatment of our employees and their family members as per their eligibility under our medical scheme. The following would be the terms of reference for empanelment:

- 1. The employees of RCB members would be provided a identity card to be produced on request by the empanelled hospital.
- 2. The empanelled hospital would confirm the identity and extend the rates fixed as per CGHS.
- 3. The employee or the eligible family member would make payment to the hospital and claim reimbursement for the same from RCB.
- 4. We are about 200 employees/student's as on date and we expect to grow at a very fast pace in the next 2 years. Moreover, other DBT institutions like National Institute of Immunology, National Brain Research Centre, and National Plant Genome Research Centre are also in the process of empanelling good hospitals. These would amount to about 1500 employees in total.

I will appreciate if you could communicate your decision on our proposal to get your hospital empanelled with RCB. As RCB sisters institute THSTI is already on your panel, Vide letter dated, 02-01-2016 Moreover RCB bill has been passed by Parliament as a Institute of National Importance (copy enclosed). In case our proposal is acceptable, I will request you to communicate the terms and conditions for the same to take this further.
