I am writing this letter to empanelment of your hospital for treatment of our employees and their family members who are covered under our medical scheme.

The Department of Biotechnology (DBT), Ministry of Science & Technology (Government of India) has established the Regional centre For Biotechnology (RCB) as a part of an emerging biotech bioscience cluster. It also seeks to establish collaborations with research institutions and hospitals around India, making this a national undertaking. This institute is located at NCR- Biotech Science Cluster, 3<sup>rd</sup> Milestone, Faridabad – Gurgaon Expressway , Faridabad- 121001 (PO Box no. 04).
